In Loving Memory of 1st Vice President, Judge Haynes H. Townsend

We deeply regret to inform you that First Vice President Judge Haynes H. Townsend passed on Tuesday, December 17, 2019. He was 64 years old.

The late Vice President Townsend possessed a unique quality that drew people to him in friendship. He greeted everyone he met with a smile and instantly made everyone feel welcome and important. People were naturally drawn to him with a desire to get to know him and help support his projects and ideas. Haynes believed kindness matters and was an example of how kindness can change the world.

A Lion for 40 years, he became a member of the Dalton Noon Lions Club in 1979. Leading up to his current office as First Vice President, he held many offices within the association, including serving several times as a club president, region chair, zone chair, District Governor, district librarian, Centennial Action Committee Member, District Honorary Committee Chairperson, District Extension Chairperson, several times as a Board Committee Member and Chairperson, District Mission 30 Coordinator, District International Relations Chairperson, Past International Director, LCIF Trustee, and Multiple District Leadership Development Chairperson. He served on the international board from 2009 to 2011, as chair of the 2010-2011 Constitution and By-laws Committee, as a board appointee to the 2010-2011 Executive Committee and was a presenter at USA/Canada leadership forums. His leadership skills and ability to encourage others helped produce real results to benefiting countless people in need.

In recognition of his service to the association, Vice President Townsend has received numerous awards including three Lion of the Year Awards, 15 District Governor Appreciation Awards, the Ervin-Crumbley Award, District 18-A Hall of Fame Award, eight International President's Awards, multiple International President's Leadership Awards, 35-Year Monarch Chevron and 40-Year Monarch Chevron, C100 Progressive Bronze Pin, Donor Pin - Immediate Recognition, Donor Pin Rocker - Lion of Commitment Pin, Donor Pin Rocker - Lion of Service Pin, two Contributing Membership Bronze awards, a Membership Key Award and a Knight of Strength Award and the association's highest award the Ambassador of Good Will Award. He was also a multi-level Progressive Melvin Jones Fellow.

The late Vice President Townsend was known to have a "servant heart" and a love for community. He started working at Fraker Hardware at age 15 and later served as Chief Magistrate Judge for Whitfield County for 22 years. He served as the chair of the Dalton-Whitfield Christmas Parade and was honored as the Judge of the Year by the State of Georgia. The *Peach Bowl* (aka Chic-Fil-A Bowl) first started by the *Georgia* Lions in 1968 and was one of his favorite events. The programs he supported will miss his guidance, but he leaves a strong sense of purpose for us all to follow. His family and many friends will call on memories of his wisdom and kindness in the days to come.

He is survived by his loving wife of 40 years, Donna Lord Townsend; daughter and her fiancé, Morgan Townsend and Travis Vitali; daughter and son-in-law, Madison and Kenneth Rutledge, Jr.; mother-in-law and father-in-law, Henry and Becky Lord; aunt, Geneva "Nene" Henton; cousins, Brian and Teresa Henton and Debra and Chuck Harris.

Talking Points for proposed Constitution & By-laws

1. Throughout: Remove No. before 26 when referring to Multiple District 26.

Justification: Continuity and clarity.

2. Throughout: Editorial corrections: adding, deleting and/or rearranging order of words/phrases; Renumbering of Articles, Sections and sub-paragraphs.

Justification: Clarity of intent, Correct grammar; Conform to established literary format.

3. Constitution Article VII Section 1. Delete entire section; replace with "The Convention site shall be deter mined in accordance with the Policy Manual in effect at the time."

Justification: Simplify State Convention planning.

4. Constitution Article VIII (New), Sec 5, (p) {new} and Sec 7 (d); Add Investment Committee.

Justification: Update financial accountability/responsibility.

5. Constitution Article VIII (New), Sec 14; Move GAT (GAT, GMT, GST) from Constitution to By-Laws; reword to LCI model language.

Justification: Comply with LCI Model

6. Constitution Article X, Sec 1; additional clarification of Convention Site selection.

Justification: Comply with LCI directives.

7. Move "Election Procedures" from Constitution to By-Laws as Article I, Section 8.

Justification: Comply with LCI Model

8. Constitution Article XIII (New); Remove current Section 1, renumber following Sections.

Justification: Covered by Automatic Update section in Amendments (Article XIV {new}).

9. Constitution Article XIV (New), Sec. 3; reduce notice time.

Justification: Comply with LCI change.

10. By-Laws Article I, Sec 8 (a), (b), (c); Election Procedures from Constitution.

Justification: Comply with LCI Model

11. By-Laws Article III, Sec 3; Clarify/update duties of Council Secretary-Treasurer.

Justification: Conform to LCI Model.

12. By-Laws Article III, Sec 4. Defer details of duties of Protocol Chairperson to Policy Manual.

Justification: Unique to Multiple District 26.

13. By-Laws Article III, Sec 7, 8, 9; Move GST, GMT and GLT from Constitution, reword to LCI Model.

Justification: Conform to LCI Model.

14. By-Law Article VI, Sec 5; delete anticipated income from expenses allowed.

Justification: Comply with LCI restrictions.

15. By-Laws Article VIII, Sec 1 (c) {old}; Delete reference to pro-rata tax for newly/reorganized clubs.

Justification: Conform to revised LCI procedure.

16. By-Laws Article VIII, Sec 2 (c) {new}; Clarify fund disbursement procedure/signature requirement(s).

Justification: Comply with LCI Model.

17. By-Laws, Article X, Section 3, Delete entire section; replace with "The Convention site shall be determined in accordance with the Policy Manual in effect at the time."

NOTICE OF ELECTIONS GLOBAL ACTION TEAM COORDINATORS

For your information and action, the terms of office of the members of the Global Action Team are coming to an end this June 30, 2020. Effective July 1, 2020, the GAT coordinators shall be selected annually. I quote from the Board Policy of Lions Clubs International.

"4. Multiple District. Multiple District Coordinators shall be selected for an annual term selected by the multiple district, in accordance with the multiple district constitution and by-laws. Multiple District Coordinators may serve multiple terms."

For Multiple District 26 the problem is that our Constitution, our By-Laws, and our Policy Manual do not stipulate how these coordinators shall be selected. In 2017 when the GAT program started, we elected the coordinators at the council of governors meeting prior to the state convention. Letters of intent were requested and out of those persons our current coordinators were elected by secret ballot.

Therefore, as the Council Chairperson in counsel with the MD Parliamentarian Lion James Rosbrugh, I am making this executive action based on precedence of our actions in 2017.

The election of members of the Global Action Team Coordinators shall be held at the council of governors meeting prior to the state convention. Those persons interested in seeking any of the positions shall submit a letter of intent to the council chairperson prior to the time for selecting the coordinators. The letter of intent may be sent by email, USPS, or personally to the chair. The council will not be responsible for failure of delivery. The positions to be filled are:

Global Leadership Team Coordinator

Global Membership Team Coordinator

Global Service Team Coordinator

Descriptions of the responsibilities of these positions may be found in our current Constitution and in our pending revised By-Laws.




